Highly productive lands should receive priority for food production and competing uses allowance be a rare exception.

Could be much better focus on soils and the value and importance for food production.

Not considered at all well and some developers may carry greater weight when such applications are considered. And the land costs maybe tipped towards development which is not acceptable.

There should Central Government Polices which clearly state to Regional and District Councils the rules that must be followed to protect highly productive lands.

# Clause

How is highly productive land currently considered when providing for rural-lifestyle development? Can you provide examples? **Notes** 

Rural lifestyle blocks can lead to the loss of highly production lands and such lifestyle blocks should be restricted to lower level or non productive lands.

# Clause

How should the tensions between primary production activities and potentially incompatible activities best be managed? **Notes** 

Use and management of productive lands should have priority with on going secure rights.

How can reverse sensitivity issues at the rural-urban interface best be managed?

#### Notes

Incoming urban dwellers should not have a right to affect the existing users practices provided they are involved with food production.

Yes there is a major problem and large areas of productive lands are lost annually from the production of food. When at the same time the need for home grown food is increasing with the increase in the population.
