1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the Overseas Market Access Requirements for caprine semen to Nepal, CAPSEM.NP dated 22 June 2016;
- (ii) the determination under section 62(1) of the format and content of the official assurance for caprine semen to Nepal.

This notice takes effect from the 22 June 2016.

2. Nepal requirements

Caprine semen exported from New Zealand to Nepal must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the caprine semen does not satisfy the conditions in the notice. Likewise, if the caprine semen does not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

VETERINARY CERTIFICATE

I,, an Official Veterinarian of the New Zealand Ministry for Primary Industries, certify, after due enquiry with respect to the donor animal(s) and semen identified in this zoosanitary certificate, that:

1. Country freedom

1.1 New Zealand is free of Aujeszky's disease, anthrax, foot-and-mouth disease, bluetongue, caprine brucellosis (*Brucella melitensis*), contagious agalactia, contagious caprine pleuropneumonia, scrapie, peste des petits ruminants, Salmonellosis (*Salmonella Abortusovis*), and sheep & goat pox.

2. Centre veterinarian

- 2.1 The centre veterinarian who supervised the collection and processing of this semen is approved by the New Zealand Ministry for Primary Industries.
- 2.2 The approved centre veterinarian is responsible for:
 - 2.2.1 isolating the donor animal(s) from all other ruminants not of equivalent health status prior to semen collection for this consignment
 - 2.2.2 supervising the isolation period
 - 2.2.3 supervising the blood sampling of the donor animal(s) and collection and processing of the semen.

3. Health status of the donor animal(s) and the collection centre

- 3.1 The donor animal(s) resided only on properties where bovine tuberculosis has not been diagnosed in sheep or goats during the three (3) years immediately prior to collection.
- 3.2 The donor animal(s) showed no clinical signs of Johne's disease during the collection period.
- 3.3 For caprine arthritis/encephalitis:
 - either [3.3.1 the donor animal(s) originated from a flock where no cases of caprine arthritis/encephalitis was diagnosed in the flocks of origin during the past three years, and also that no animal(s) from a flock of inferior health status was introduced into these flocks during that period]*
 - or [3.3.2 the donor animal(s) was tested, with negative results, for caprine arthritis/encephalitis infection within the thirty (30) days prior to entry onto the semen collection centre, using an AGID or an ELISA, and during that time was kept isolated from other animals not of the same health status.

- On the day of the first collection of semen for this consignment, the donor animal(s) were examined by the centre veterinarian and found to be clinically healthy.

4.	Collection	of semen

- 4.1 At the time of collection the donor animal(s) was free of any prohibition or quarantine restrictions.
- 4.2 During the seven (7)-day period immediately prior to semen collection and during the period of semen collection the donor animal(s) were kept isolated from goats not of equivalent health status.

5. Semen collection and storage

- 5.1 The semen in this consignment was collected, handled and stored in accordance with the relevant sections of the OIE *Code* for Bovine and Small Ruminant Semen.
- 5.2 The semen was identified, and has been stored in fresh liquid nitrogen since the end of the collection period until export, under the supervision of the Official Veterinarian in containers in which no biological material, other than semen, embryos or ova of equivalent health status, was held.
- 5.3 The container for export was:

or [4.3.2 prior to loading, emptied and inspected and any loose straws removed. The shipper, including all surfaces contacting the straws, was disinfected.
