

# Tell us about a transfer of ETS responsibilities

## Forestry in the Emissions Trading Scheme – post-1989

Use this form to tell us about a transfer of ETS responsibilities because of:

- a sale of land
- a transfer of a registered forestry right, registered lease, or Crown conservation contract, or
- the granting of a registered forestry right or registered lease.

This form must be submitted to Te Uru Rākau – New Zealand Forest Service within 20 working days of the date of transfer. It must be completed by both parties.

If you are granting a registered forestry right or registered lease, you must provide proof of consent for participation in the ETS to transfer to the forestry right, or lease, holder. To do this, complete an 'Opt-in to transfer ETS responsibilities' form. Consent must be provided before you submit the transfer form.

If a forestry right, lease, or Crown conservation contract is expiring or terminating you must use the 'Tell us about the expiry or termination of a registered forestry right or lease' form.

If a transfer is by succession you must use the 'Tell us about a change of land ownership by succession' form.

### How to submit your application

If the post-1989 forest land is registered as standard forestry:

1. Log-in to Tupu-ake – Forestry ETS online services, available at [www.mpi.govt.nz/ets-online-system/](http://www.mpi.govt.nz/ets-online-system/)
2. Select the service **Post-1989 forest land (standard) > Tell us about a change to ownership, rights or leases > Tell us the land owner has changed, Tell us a forestry right or lease has been registered, or Tell us about agreed changes to forestry right or lease holders.**
3. Upload the completed form and your shapefile to the file upload on the main summary page.

If the post-1989 forest land is registered as permanent forestry:

1. Log-in to Tupu-ake – Forestry ETS online services, available at [www.mpi.govt.nz/ets-online-system/](http://www.mpi.govt.nz/ets-online-system/)
2. Select the service **Post-1989 forest land (permanent) > Tell us about a change to ownership, rights or leases > Tell us the land owner has changed, Tell us a forestry right or lease has been registered, or Tell us about agreed changes to forestry right or lease holders.**
3. Upload the completed form and your shapefile to the file upload on the main summary page.

### Next steps

We will process your notification and contact you about the outcome.

If this transfer results in you having 100 or more hectares of forest land in the ETS, you will need to establish sample plots on your land for measuring your forest. This is sometimes known as the Field Measurement Approach. Find out more on our website:
