2. Select **Post-1989 forest land (standard) > Apply to join or leave the ETS > Apply to register post-1989 forest land** from the services menu.
3. Upload this form and your application to register in the ETS to the file upload on the main summary page.

If the land is being registered as permanent forestry:

1. Log-in to Tupu-ake – Forestry ETS online services, available at [www.mpi.govt.nz/etsonline](http://www.mpi.govt.nz/etsonline)
2. Select **Post-1989 forest land (permanent) > Apply to join or leave the ETS > Apply to register post-1989 forest land** from the services menu.
3. Upload this form and your application to register in the ETS to the file upload on the main summary page.
