The Minister for Primary Industries Nathan Guy has stated 'biosecurity is my number one priority'. With the increasing volume and variety of risk goods being imported into New Zealand, MPI is ensuring a robust approach is taken to the management of all facilities to protect the environment and primary industries.

Facility stakeholders have told MPI they want more incentives for those that comply, tougher enforcement action against those who do not comply, and better targeting of MPI resource to risk. Therefore, MPI is "raising the bar" to ensure operating an MPI approved facility is a privilege, not a right.

Know the Enemy: Giant African Snail

Recently, several giant African snails, considered to be one of the most damaging land snails in the world, have been found on sea containers from Honiara in the Solomon Islands at Australian ports. This snail is not established in NZ and would pose a threat to agriculture, the environment and human health if it became established.

It has a voracious appetite and can attack more than 500 different kinds of plants, including ornamentals and most species of vegetables. It is quite large with a relatively long conical shell, usually light brown with alternating brown and cream bands.

It can be transported attached to containers (air and sea), crates, machinery, motor vehicles and plant material. Cargo and containers from high-risk giant African snail infested countries are inspected by MPI on arrival.



If you see anything that looks like this pest on imported risk goods please catch or spray it and call MPI on 0800 80 99 66

The advice I would give to operators would be to try to keep as up-to-date as possible with the current state of biosecurity in New Zealand, which may provide a better understanding of the importance of their role as an operator. It is also important that operators are aware of their legal obligations once they are approved, and that they must inform MPI of any changes at their facility, for example, change of operator, moving location, change of company name, etc, to avoid non-compliance penalties.


Review of TFGEN

A review of the MPI Standard - General Transitional Facilities for Uncleared Risk Goods (TFGEN) and the associated guidance document (GD) is underway. TFGEN specifies the requirements that TFs must have and their operators must follow. The review will provide clarification and remove areas of ambiguity. Updated requirements will provide the detail to specify what MPI needs regarding information on imported risk goods, how they will be managed and what information must be recorded. Any changes that need to be made to TFGEN will be formally and thoroughly consulted with stakeholders and will be finalised by 30 June 2015. Wood Packaging Material

There is a contradiction in the accredited person training material and online Operating Manual Template around what actions APs should take with wood packaging material that is not ISPM15 stamped. To clarify, wood packaging material should be dealt with as per the following:

- ISPM15 compliant wood packaging material (i.e. with a stamp as shown in the picture) must be checked by the AP. If there are any signs of contamination then MPI must be contacted.
- If wood packaging material is not stamped, APs are to contact MPI for further instruction.



So regardless of whether the wood packaging material is clean and free from contamination, APs cannot conduct inspections of wood packaging material that is not ISPM15 stamped.

Recent Finds

Air Containers & Biosecurity Risk

MPI is revising the current Import Health Standard for importing air containers. This is because air containers are known to have introduced invasive pests into countries. For example, in 2001 MPI spent \$1.5 million to eradicate the red imported fire ant that was found near the Auckland airport.

This revision will include aligning this standard with other relevant standards as well as clarifying the roles and responsibilities of transitional facilities operators receiving air containers and the biosecurity repercussions of not complying.
