1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for Dogs and Cats to Saint Vincent and the Grenadines PETANI.VC dated 25 August 2016;
- (ii) the determination under section 62(1) of the format and content of the official assurance for dogs and cats to Saint Vincent and the Grenadines;

2. Saint Vincent and the Grenadines requirements

Dogs and cats exported from New Zealand to Saint Vincent and the Grenadines must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the dogs and cats do not satisfy the conditions in the notice. Likewise, if the dogs and cats do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified

- 3. The animal must be transported in accordance with the International Air Transport association (IATA) Live Animal Regulations as appropriate.
- 4. If you are planning on returning to New Zealand with your pet in the future, please contact the animal imports group at MPI to obtain information on importing pets back in New Zealand. We strongly suggest that this is done before your pet is exported from New Zealand as not every country can meet the New Zealand import conditions, and so you may not be able to import your pet back into New Zealand.
