Wine (Fruit Wine, Vegetable Wine, Mead, Wine Product, and Non-New Zealand Grape Wine – Export Requirements Exemption) Notice 2014

#### 1 Title

This notice is the Wine (Fruit Wine, Vegetable Wine, Mead, Wine Product, and Non-New Zealand Grape Wine – Export Requirements Exemption) Notice 2014.

# 2 Commencement

This notice comes into force on 24 March 2014

# **Preliminary Provisions**

# 3. Purpose

The purpose of this Notice is to facilitate the development of overseas markets for New Zealand wine by exempting exporters of certain classes of wine and wine product from certain export requirements as specified under this Notice.

# 4. Application

- (1) This Notice applies to any exporter of fruit wine, vegetable wine, mead, wine product, or non-New Zealand grape wine who exports no more than 110 litres of fruit wine, vegetable wine, mead, wine product, or non-New Zealand grape wine in any one consignment as a trade sample or otherwise to assess any overseas market for the initial development of that market.
- (2) For the avoidance of doubt, nothing in this notice affects the requirement for all winemakers to operate under a registered wine standards management plan under section 9 of the Act.

#### 5. Interpretation

(1) In this Notice, unless the context of the Notice otherwise requires-

Act means the Wine Act 2003

**trade sample** means a fruit wine, vegetable wine, mead, wine product, or a non-New Zealand grape wine that is-

- (a) not intended for re-sale and includes commercial samples and show samples;
- (b) is in a bottle that is clearly marked or clearly indicates that it is not for sale

**non-New Zealand grape wine** means any grape wine derived either solely or in part from grapes grown outside of New Zealand

wine product means a food (as defined in the Food Act 1981) containing no less than 700 ml/L of wine which has been formulated, processed, modified, or mixed with other foods such that it is not wine and where the wine product operations are included in a wine standards management plan for the purpose of section 10 of the Act.

(2) Any term or expression that is defined in the Act and is not defined in this Notice has the same meaning as in the Act.



6. Exemption for exporters of fruit wine, vegetable wine, mead, wine product, and non-New Zealand grape from prerequisites for export

An exporter who exports no more than 110 litres of fruit wine, vegetable wine, mead, wine product, or non-New Zealand grape wine in any one consignment as a trade sample or otherwise to assess any overseas market for the initial development of that market is exempted from the requirement to be registered as an exporter under section 37 of the Act.
