Challenge	 This prototype provides an opportunity for MPI to work with the Trust to deliver a report and explore 'optimal land use on small blocks focusing on economic returns for the landowners.' This improved knowledge and capability will hopefully see an increase in productivity and ultimately better returns for the Trust. The report will allow the Trust and its trustees to gain confidence in making more informed decisions about the land, building scalability and possible investment opportunities from other entities within the rohe of Ngati Pukeko and Ngati Awa. 	
Purpose of the Project:	The Trust are seeking support to commission a prototype report on optimal land use on small land blocks focusing on economic returns for the land owners and a case study to bring other trusts into the fold.	
Project Outcomes:	 The projected outcomes include: providing economically viable options for bringing the identified Māori land blocks into production and a case study that captures key learnings which can be utilised in other areas for similar work. The above project outcomes will allow for: The Trust will have compelling evidence by way of a full report to not only share with its shareholders but also to share with other land trusts within Ngati Pukeko and also within Ngati Awa to collectively work together to make better use of the land. Identify the economic and social implications of transitioning from under-utilised land to well-connected and productive land use will be confirmed.
