NOVEMBER 2016 EARTHQUAKE IMPACTS IN HURUNUI, KAIKŌURA AND MARLBOROUGH DISTRICTS









The fund is to assist rural people whose principal income comes from a primary industry. Funding is available to help pay for costs associated with:

- Restoration of uninsurable primary sector infrastructure;
- Re-establishment of uninsurable pasture (on cultivatable land), crops, and forestry;
- Initial clean-up of silt and debris (where uninsurable).

This includes on-farm access tracks, bridges without sides, dams, reservoirs, water reticulation, and fencing.

- Any grant will be a contribution towards repairs, up to a maximum of 50% of the cost.
- The total claim must exceed \$12,000 for you to be considered for assistance.
- An excess of \$5000 will be deducted from the 50% that is eligible for funding.
- The maximum any one entity could receive from the Fund is \$50,000.

WHAT IS PRIMARY INDUSTRY?

"Primary industry" for this purpose includes the primary production of meat, wool, or dairy products, arable farming, aquaculture, horticulture, viticulture, forestry, sharemilking, an orchard, apiculture, herb or flower growing, a market garden, poultry farming, and fishing (including pāua, crayfish, finfish) but does not include hobby farming (such as lifestyle blocks).
