Biosecurity clearance cannot be given to your pet, or any other animal in the same consignment, if ticks or fleas are detected. If this happens, you have three options. At your cost, your pet will either need to:

- go to an approved quarantine facility for treatment +/- testing;
- return to its country of origin (if permitted);
- be euthanased.

WHAT TO EXPECT IF FLEAS ARE DETECTED

Normally, your pet(s) will need to stay in a quarantine facility for at least **several days** until it is cleared. As a guide, you can expect costs of about **\$1000 per animal in the consignment**.

WHAT TO EXPECT IF TICKS ARE DETECTED

Any **cats** in the consignment will normally need to stay in a quarantine facility for at least **several days** until they are cleared. As a guide, you can expect costs of about **\$1000 per cat**.

Any **dogs** in the consignment will normally need to stay in a quarantine facility for at least **a few weeks**, in order to test for tick-borne diseases. Dogs cannot be released until negative test results have been received. As a guide, you can expect costs of about **\$3000 per dog**.
