Consultation on proposed Processing of Poultry Code of Practice Part 2 Good Operating Practice

The Ministry for Primary Industries (MPI) has updated the Processing of Poultry Code of Practice Part 2 Good Operating Practice.

The current Processing of Poultry Code of Practice has been combined into a single document and updated to reflect the current legislation including the Animal Products Specifications for Products Intended for Human Consumption Notice 2016 and Australia New Zealand Food Standards Code. New chapters addressing generic good operating practices and those for Design and Construction have also been included in the proposed Code.

MPI intends to complete the revision of the existing parts and the development of new chapters over time. The proposed Code Part 2: Good Operating Practice is intended to replace the existing documents:

- Part 2, Chapter 2: Repairs and Maintenance
- Part 2, Chapter 3: Hygiene and Sanitation
- Part 2, Chapter 5: Slaughter and Dressing
- Part 2, Chapter 9: Secondary Processing

MPI is seeking feedback on the proposed Code.
