

I would like to make a formal objection about the 'Marlborough Salmon Relocation'

I only object to the relocation of one farm and that is salmon farm 3 being moved into the middle of the Pelorus sounds.

I have grown up in the sounds on Forsyth Island and have travelled the Pelorus sounds too many times to count. Now I don't live in the sounds but being a seafood processor I am still regularly on a boat and travel down the Pelorus I feel having a salmon farm relocated to the middle of the sounds is a very dangerous move. I have never had a marine accident and when I am travelling by boat at night I travel straight down the middle of where I am going as this is generally classed as the safe zone. From a navigation point of view this salmon farm I feel could cause problems with marine traffic and maybe even cause accidents. Yes, some bigger boats have navigation systems that will tell them what's around and during the day it wouldn't be an issue but It could become an issue at night with people without the navigational equipment.

I have no problem with the other farm relocations however this one to me isn't a good idea. From a boating navigational point of view nothing should be down the middle. I say let's keep the middle as a safe zone and not relocate a salmon farm smack bang in the middle.
