### REGULATIONS

#### [Part 2 – Risk Management Programmes \(RMPs\)](#)

An RMP is a programme designed to identify, control, manage, eliminate or minimise hazards and other risks during processing of animal material and products. Requirements issued under Part 2 and guidance cover the following information;

- **General requirements for RMPs**
- **Waivers to provide evaluation report**
- **RMP manual**
- **Codes of practice (COP) and RMP templates**

#### [Part 3 – Regulated Control Schemes \(RCSs\)](#)

RCSs are special regulatory regimes to provide for cases where it is inappropriate or impractical to manage risk factors under an RMP or where special provision is required for the purposes of overseas market access requirements. There are RCS covering the following areas;

- **Transport of Animal Products Requiring an Official Assurance**
- **Export of dairy quota products**
- **Dairy industry national residue monitoring programme**
- **Raw milk for consumers** (*for raw milk products, e.g. raw milk cheese, refer to Specification for raw milk products in Part 4*)

#### [Part 4 – Animal Product Standards and Specifications](#)

This part provides for the setting of standards that must be met by any animal product intended for trade or processed for reward before it may be considered fit for intended purpose. This part also allows for the setting of specifications that may be necessary to ensure such standards are met. Requirements issued under Part 4 and guidance covers the following information;

- **Dairy Processing**
- **Disposal of non conforming dairy material or dairy product**
- **Specification for raw milk products**
- **Laboratory testing**

## [Agricultural Compounds and Veterinary Medicines Act 1997](#)

### REGULATIONS

The ACVM Act covers agricultural compounds used in the management of plants and animals. It includes veterinary medicines, pet food, stock feeds, fertilisers, pesticides, and vertebrate toxic agents. It manages their risks to trade, animal welfare, public health and agricultural security. The ACVM Act prohibits an agricultural compound being imported, manufactured, sold or used in NZ unless authorised. The two main authorisation mechanisms are registration of a “trade name product” with conditions imposed to manage risk to acceptable level, and exemption of a product from registration by regulations for those products having low risks.
