I have also provided you with a copy of their response to our visit, resulting in 337 tonne of Hoki quota being redeclared on their returns dating back to Oct 1994 to 20 August 1996. The Hoki caught and processed since 20 Aug 1996 has been correctly declared as TRF. (Copy of letter attached for your info).
