Products in 'pending approval pile'

To date we have delayed invoicing 'pending' products that are waiting for label, PDS, EPA (or any other) approval, which sometimes takes months. Unfortunately, some applicants have misunderstood this policy and have linked the requirement to pay for assessing/processing an application to gaining approval. This has caused us a number of issues when eventually we raise an invoice. For example, applicants who have not been successful in gaining EPA approval have withdrawn their applications and then objected to paying when billed for the work already completed.

Please note the following change to our invoicing procedure. If your pending application is awaiting a revised label or PDS, then you will not be billed prior to us receiving the final documentation as we expect a PDS or label to be provided promptly. HOWEVER, if your application is awaiting an EPA approval or the promulgation of an MRL, you will be invoiced for the work and time already undertaken on the application, and then a further invoice will be raised for the additional technical assessment. This change will take effect from **1 February 2015**.

Data assessor update

Since the October workshop (see November issue for details) we have already received eight applications from data assessors who wish to become 'listed'. Four of these applicants have been approved as provisionally listed data assessors, with the other four in progress.
