NZTA: ROAD OPENING ON TRACK BY CHRISTMAS



Everyone is hoping that heavy rain and more shakes stay away this year, so State Highway 1 north of Kaikōura can open as planned on Friday 15th December.

Open doesn't quite mean complete – there will be some unsealed surfaces, lane closures and stop/go work sites. Plus there will be months of overnight closures while work is carried out.

Trucks and other heavy vehicles will be able to use the road. It is still being assessed for safe use for High Productivity Motor Vehicles.

2017 PRIMARY INDUSTRIES EARTHQUAKE RECOVERY FUND: COMMUNITY GROUP PROJECTS

Eight projects have confirmed funding to tackle a shared problem or to develop new opportunities, with a focus on long-term land use diversification, research, and restoration for earthquake-affected areas.

Funded over three years, these community-led projects are an important part of helping the regions' producers to build on recovery. They cover sheep and beef, dairy, viticulture, seafood, and water resources.

The community groups will report progress throughout the projects, sharing findings and learnings with the community they are representing, so everyone can benefit from this recovery assistance.

I am very pleased to tell you that the Farm Land & Business Recovery programme of three co-ordinated projects was signed with MPI on 2 November 2017 (Projects 1, 2 and 3 above).



This three-year programme, under the Primary Industries Earthquake Recovery Fund (ERF), has been developed with the input of many parties – including earthquake-affected farmers, Federated Farmers, Beef+Lamb NZ, Hurunui District Council and ECan. Beef+Lamb NZ have signed the contract on behalf of a collaborative establishment group keen to support farmers in the earthquake recovery process.

The programme is farmer-led and is kicking off with groups forming in Marlborough, Waiau/Kaikōura, and Cheviot/Conway areas.

The programme has two aims: first, to look at land stability and recovery within existing farm systems, and second, to help farmers find options for future land use. Activities will be determined by local priorities and then coordinated across the affected areas. This will allow sharing of knowledge and ideas, and observation of field trials. Participating farmers will be able to pool their ERF Advisory Services (option 2) funding if they want to – we see it will be more cost-effective for farmers to take up expert advice together.

2017 PRIMARY INDUSTRIES EARTHQUAKE RECOVERY FUND: ADVISORY SERVICES

The Earthquake Recovery Fund supports long-term land use changes in the affected Hurunui, Kaikōura and Marlborough regions.

\$5000 ADVISORY SERVICES FOR AFFECTED FARMERS

WHO IS THIS FOR?

You can use this fund if your business meets all three criteria:

- Primary industry businesses (includes dairy, sheep, beef, deer, arable, horticulture, forestry, farm forestry, pigs, poultry, viticulture, land-based aquaculture but excludes wild fisheries) in the Hurunui, Kaikōura and Marlborough regions.
- Main business income comes from the primary sector.
- Your property has some form of damage from the November 2016 Earthquakes and you wish to access funding for advice on earthquake recovery.

HOW DO I APPLY?

Complete a simple 5-step process to access advisory funding for your primary industry business:

APPROVED PROVIDER Check the list of approved providers on the MPI website.

FIND AN



COMPLETE DETAILS ABOUT

YOURSELF Fill in the simple MPI form, supplied by the selected provider, to tell us about yourself and the work proposed.



CHOOSE A PROVIDER

Select a provider as your adviser and give them a call to discuss your business/land issues and to scope the work required.



AGREEING COSTS The provider gives you either a quote for the scope of work,

or a cost estimate. When you agree with it, the quote or estimate goes with the form to MPI for approval of the work.

WORK BEGINS

Once approved by MPI, up to \$5000 worth of advisory work can start. The funding will be paid to the approved provider when their work is completed.

WHO ARE THE MPI-APPROVED ADVISORY SERVICES PROVIDERS?

These are on the MPI website at: **www.mpi.govt.nz/advisory-services**. If you want to use a company for advice that is not on the MPI-approved list, they can apply to MPI for approval to do your advisory work by:

SELECTING AN APPROVED PROVIDER

You choose the provider you want. We suggest viewing the approved providers' summaries and completing some due diligence, so you are confident they can deliver what you need. Discuss your needs with the provider, and give good detail on the work so everyone is clear on the service to be provided and the outputs to be delivered.

DO I HAVE TO USE A LOCAL PROVIDER?

The choice is yours. Some approved providers are not based in the affected regions, but have been approved due to their abilities. You can select the best provider for your needs, bearing in mind expertise, timeframes, capacity and availability.

DO I HAVE TO APPLY OR COMPLETE ANY APPLICATIONS?

You do not have to supply forms to MPI. Your approved provider will work with you to complete a simple form for the work required; and will provide the quote for work.

HOW MUCH CAN I GET?

MPI will fund up to \$5000 +GST per property for advice through MPI-approved advisory providers. MPI will pay approved advisory providers on receipt of forms confirming the work with you is completed, so no direct payments will be made to landowners or land managers.

MPI's funding is limited to a maximum of \$5000 + GST, no matter how much the total cost of the final work. The approved provider's quote for work will state costs covered by the MPI funding and if you may need to pay any other costs separately.

If you have two independent properties, you can claim for each one. If they are run as part of one operation (same management), you can only claim once.

HOW LONG IS FUNDING FOR ADVISORY SERVICES AVAILABLE FOR?

MPI has a \$500,000 fund that is available for earthquake recovery advisory services until 30 June 2018. From 1 July 2018 to 30 June 2019 a separate \$500,000 will become available for further advisory services applications.

We recommend applying now to ensure access to this limited funding.

WHAT ADVISORY WORK IS COVERED UNDER THIS FUND?

- Strategic planning, including farm business and whole farm plans
- Land management and sustainable management techniques
- Farm environmental plans
- Analysis of farm systems
- Analysis and mitigation of risks
- Risk and recovery management
- Business continuity establishment and documentation of farm systems

- Modelling farm change scenarios
- Alternate land use options
- Technical advice soil, pastures, animal production, feed budgeting
- Financial planning and decision support
- · Budgets and cash flow forecasting
- · Farm accounts analysis
- Forestry advice
- Strategic advice

Out of scope:

- Proposals for business expansion
- Any work that is not related to earthquake recovery
- · Properties outside of Hurunui, Kaikoura and Marlborough.
