### 1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the overseas market access requirements for paua (NZ abalone) to Australia AQUPAU.AU dated 18 February 2018;
- (ii) the revocation and replacement of PAUANEC.AU paua (NZ abalone) to Australia dated 7 June 2016;
- (iii) the determination under section 62(1) of the format and content of the official assurance for paua (NZ abalone) to Australia.

This notice takes effect from the 19<sup>th</sup> of February 2018.

### 2. Australia requirements

Paua (NZ abalone) exported from New Zealand to Australia must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

### **Explanatory note:**

If the zoosanitary certificate is not certified then the paua (NZ abalone) does not satisfy the conditions in the notice. Likewise, if the paua (NZ abalone) does not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

**NOTES:** This certificate replaces the certificate agreed in 2016. It is updated from an

Australian Department of Agriculture Import Permit for New Zealand blackfoot paua dated effective from 24 November 2017. The certificate has been updated to align with the new terminology system for the Department of Agriculture and Water Resources. It was accepted by the Australian Department of Agriculture and Water

Resources on 14th February 2018.

- 1. All consignments must be accompanied by a valid Import Permit or a means to allow identification of the Department of Agriculture Import Permit.
- 2. The Importer must lodge a Quarantine Entry for each consignment.
- 3. Consignments must be addressed and sent to the Department of Agriculture and Water Resources at the port of arrival.
- 4. Live animals must be shipped in secure, escape proof containers that meet the container requirements specified in IATA Live Animals Regulations. Consignments must be labelled "ATTENTION LIVE ANIMALS UNDER QUARANTINE" and must be clearly labelled with the scientific name and approximate number within.
- 5. Clause 1.3: the seal(s) may be either an official seal(s) of the government veterinary administration or a seal(s) provided by the source institution.
- 6. Consignments must meet all of the conditions of administration and post arrival quarantine requirements specified on the import permit.
- 7. Consignments that do not meet the Department of Agriculture and Water Resources import conditions will remain in biosecurity control, be exported or disposed of without recompense.

Section 61A of the Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market'.
