1. Statutory authority

Pursuant to section 167, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the Overseas Market Access Requirements for ovine embryos (in vivo) to the Falkland Islands, OVIEMB.FK dated 22 March 2018;
- (ii) the determination under section 62(1) of the format and content of the official assurance for ovine embryos (in vivo) to the Falkland Islands.

This notice takes effect from the 29 March 2018.

2. Falkland Island requirements

Ovine embryos exported from New Zealand to the Falkland Islands must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the ovine embryos do not satisfy the conditions in the notice. Likewise, if the ovine embryos do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

1 COUNTRY FREEDOM

- 1.1 New Zealand is free of rinderpest, Rift Valley Fever, peste des petits ruminants, contagious agalactia, bluetongue, enzootic abortion of ewes (chlamydiosis), sheep and goat pox, maedi-visna and Q fever.
- 1.2 New Zealand is officially recognised free from foot and mouth disease (FMD) where vaccination is not practised by the World Organisation for Animal Health (OIE).
- 1.3 New Zealand is free of Scrapie in accordance with the recommendations established in the Terrestrial Animal Health Code of the World Animal Health Organisation (OIE).

2 RESIDENCY STATUS OF DONOR ANIMAL(S)

- 2.1 The donor animal(s) has been continuously resident in New Zealand since birth, or since import from Australia.
- 2.2 The donor animal(s) has been continuously resident in the herd of origin or in an MPI approved collection centre from the time of insemination or mating until embryo collection is completed, and during that time was kept isolated from animals not of an equivalent health status.

3 HEALTH STATUS

- 3.1 The donor animal(s) and all in contact animal(s) was healthy and free of clinical evidence of infectious diseases that are transmissible by embryo transfer on the day of collection.
- 3.2 For bovine tuberculosis:
 - 3.2.1 During the three (3) years prior to collection, the donor animal(s) has not been on premises with cattle or deer herds classified as infected under the National Pest Management Strategy for bovine tuberculosis.
 - 3.2.2 No clinical case of bovine tuberculosis has been diagnosed in sheep or goats on the premises of origin during the three (3) years prior to collection.
- 3.3 The donor animal(s) was tested, with negative results, for *Brucella ovis* infection within thirty (30) days prior to collection, or post collection, using a CFT or an ELISA.

- 3.4 The testing was undertaken at a laboratory approved by the New Zealand Ministry for Primary Industries.

4 EMBRYO COLLECTION, PROCESSING AND STORAGE

- 4.1 The embryos were collected, processed, identified and stored in accordance with the recommendations set out in the OIE Terrestrial Animal Health Code and the International Embryos Transfer Society (IETS) Manual.
- 4.2 The embryos were treated with trypsin in accordance with the recommendations of the International Embryos Transfer Society (IETS) Manual.
- 4.3 The embryo(s) were stored under the supervision of an Official Veterinarian in containers with new (unused) liquid nitrogen, in which no biological material other than semen or embryo(s) of equivalent health status was held.

1. A copy of a valid Import Permit, obtained from The Department of Agriculture, must accompany the shipment to the Falkland Islands.

- 2. For Clause 3.5 Where imported semen is used:
 - the semen must meet the current zoosanitary requirements between the country where the ovine semen is collected and the Falkland Islands.
 - **b.** At the time of arrival in NZ the semen was transported directly to an MPI approved centre where it was stored under the supervision of the Approved Veterinarian; in accordance with the OIE Terrestrial Animal Health Code until embryo production.
