NOTICE UNDER THE BIOSECURITY ACT 1993

SECTION 131 - DECLARATION OF CONTROLLED AREA AND NOTICE OF MOVEMENT CONTROLS AND PROCEDURES IN RESPECT OF QUEENSLAND FRUIT FLY - Bactrocera tryoni

Commencement

1. This Declaration and Notice takes effect at 2 pm on 2 July 2019.

Revocation of previous Declaration of Controlled Area and Notice of Movement Controls

This Declaration and Notice revokes and replaces the Declaration of Controlled Area and Notice of Movement 2. Controls and Procedures which took effect at 12.00 on 29 May 2019 in respect of Queensland Fruit Fly (QFF) detected in Northcote, Auckland.

Controlled Area Declaration

- Pursuant to section 131(2) of the Biosecurity Act 1993, I hereby declare that the area described in Schedule 1 3. ("the Controlled Area") is the area that is controlled in order to:
 - (a) Enable the limitation of the spread of Queensland Fruit Fly (Bactrocera tryoni) (QFF), being an unwanted organism under the Biosecurity Act 1993:
 - Minimise the damage caused by QFF;
 - (c) Protect New Zealand from an incursion of QFF;
 - (d) Facilitate the access of New Zealand products to overseas markets; and
 - (e) Monitor risks associated with the movement of QFF from parts of New Zealand where the QFF status is unknown.

Notice of Movement Controls

- Under section 131(3)(a) of the Biosecurity Act 1993, I hereby give notice that, except with the written permission of 4 an inspector or authorised person appointed under s 103 of the Biosecurity Act 1993, and in compliance with any conditions imposed by an inspector or authorised person:
 - Things listed in Schedule 3 (under Zone B) that are in the Controlled Area Zone B must not be moved outside Zone B: and
 - Things listed in Schedule 3 (under Zone B) that are in Controlled Area Zone B, must not be disposed of by putting out for collection by rubbish or recycling collectors.
- For the avoidance of doubt: 5.
 - (a) Things listed in Schedule 3 (under Zone B) may be moved into Zone B, from outside Zone B.

SCHEDULE 1 - Description of Controlled Area

The following areas are included in the Controlled Area and subject to this Notice:

Zone A – there is no Zone A currently in effect.

Zone B (yellow area)

Controlled Area Zone B is the area which has the boundaries described below, and is defined as Zone B in the map in Schedule 2:

- (a) Beginning at the intersection of Exmouth Road and Sylvan Avenue in Northcote; then
- (b) Proceeding south-east on Exmouth Road to the end of that road, and continuing in a straight line across the Northern Motorway (State Highway 1) to the Auckland harbour mean high water mark ("the shoreline"); then
- (c) Proceeding to a point 200m out to sea from the shoreline; then
- (d) Turning south and proceeding in a southerly direction, following a line 200m out to sea from the shoreline at all times, towards a point 200m east of the shoreline of Stokes Point Reserve; then
- (e) Turning south-west in a south-westerly direction to a point following a line 200m out to sea from the shoreline at all times, towards a point 200m south of the shoreline of Stokes Point Reserve; then
- (f) Turning westerly, and proceeding in a westerly direction in a straight line until level with a point 200m from the shoreline where Chelsea View Drive intersects with Onetaunga Road and passes along the eastern boundary of 91 Onetaunga Road in a northerly direction; then
- (g) Proceeding north along Chelsea View Drive until the intersection of Mokoia Road; then
- (h) Turning east onto Mokoia Road and then immediately north onto Glenwood Avenue; then
- (i) Proceeding in a northerly direction along Glenwood Avenue; then
- (j) Turning north-east onto Glenbush Place; then
- (k) Proceeding in a straight line in an eastern direction on the south side of 7 Glenbush Place through the bush to the walking path between 42 and 44 Mahara Avenue; then
- (I) Crossing Mahara Avenue onto John Court Street; then
- (m) Heading in a northerly direction along the eastern boundary of the Birkenhead Pool and Leisure Centre until the southern boundary of the park and sports field area; then
- (n) Proceeding east along the southern boundary of the sports fields until Birkenhead Avenue; then
- (o) Proceeding along Birkenhead Avenue in a northerly direction, to the intersection of Birkenhead Avenue and Pupuke Road: then
- (p) Turning east on Pupuke Road and proceeding along Pupuke Road until the intersection with Raleigh Road; then
- (q) Turning south-east onto Raleigh Road and proceeding along Raleigh Road to the roundabout, then
- (r) Continuing straight through the roundabout on to Exmouth Road; and then
- (s) Continuing south-east along Exmouth Road to the intersection of Exmouth Road and Sylvan Avenue.

Specific Properties in Zone B


Where a property is bisected by the boundary of Controlled Area Zone B, the entire property shall be included in the Controlled Area Zone B.

SCHEDULE 3 - Things subject to Movement Controls

Zone B

- (a) Zone B fruit and vegetables, meaning all whole fruit and vegetables grown inside Zone B, except for:
 - (i) leafy vegetables; and
 - (ii) root vegetables; and
 - (iii) cooked, processed, preserved, dried, frozen and canned fruit.
- (b) Packaging materials associated with Zone B fruit and vegetables.
- (c) Soil and planting medium attached to, or in the vicinity of, fruit bearing trees grown inside Zone B.
- (d) Compost and green waste that contains Zone B fruit and vegetables.

SCHEDULE 4 – Activities not subject to Movement Controls

The following activities are not subject to movement controls:

- (a) Transport of material listed in Schedule 3 through Zone B on State Highway 1 (the Northern Motorway), provided that:
 - (i) Transit begins and ends outside the Controlled Area (Zone B);
 - (ii) No stops are made within the Controlled Area (Zone B); and
 - (iii) The material is contained and / or transported in an enclosed vehicle.

Notes for Information

Any person who wishes to obtain the permission of an inspector or authorised person to carry out a movement or activity that would otherwise be prohibited by this Notice or to obtain an exemption from an inspector or authorised person should contact the Permitting Manager on 0800 80 99 66, Option 2.
