OFFICIAL INFORMATION ACT REQUEST

I refer to your official information request on 20 May 2019 for the following: *Please provide copies of any documents relating to indigenous timber or timber products, for the period between 1 January 2018 and 1 May 2019, that are associated with or otherwise relate to:*

You have also requested 'any correspondence between the Ministry for Primary Industries (MPI) and these persons/entities concerning indigenous timber or timber products, and any applications by these persons or entities associated with the milling of indigenous timber or the export of indigenous timber of timber products'.

On 11 June 2019 MPI extended the time limit to respond to your request to 16 July 2019.

The following information is released to you under the Official Information Act 1982 (OIA):

- Correspondence between Te Uru Rākau and the parties listed above.
- Notices of Intention to Export (included, are those notices of intention to export stump material as required under the Forests Act 1949, and voluntary notices of intention to export finished product).

In the materials released where correspondence is not sent to or from these parties, and does not relate to indigenous timber or timber products, it has been removed as "not relevant to the request".

Some information has been withheld pursuant to the following sections of the OIA:

- Section 9(2)(a) to protect the privacy of natural persons.
- Section 9(2)(b)(ii) to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who is the subject of the information.

Te Uru Rākau is satisfied that in the circumstances of this case, the withholding of the information is not outweighed by other considerations which render it desirable in the public interest to make the information available.

You have the right under section 28(3) of the OIA to seek an investigation and review by the Ombudsman of our decision to withhold information.
