Meeting summary

- The Winter Grazing Taskforce's fourth meeting was held on 27 September 2019 in Wellington. The primary aim of the meeting was to discuss the content and recommendations of the final report of the Taskforce's findings to be released in October.
- The summaries from the 5 and 12 September meetings were reviewed and agreed as a true and accurate reflection.
- The Taskforce discussed responses to correspondence it had received from parties who had presented to the taskforce at previous meetings and agreed for the Chair to follow up.
- The Taskforce agreed at its previous meeting that farmers should be made immediately aware of the possibility of stricter enforcement next year as they plan for their winter 2020 feeding systems, but had not agreed on an approach to do so. The Taskforce agreed to ask the Minister's office to issue communications around this, when the 12 September meeting summary is made publically available.
- An invited speaker presented on the environmental and animal welfare challenges facing their farm staff, and the alternative management systems they are trialling and tools they have developed to support improved practice & better welfare outcomes.
- The Taskforce discussed the proposals for Action for Healthy Waterways, and noted that
 action taken would need to ensure it is not in conflict with animal welfare management. For
 instance, pugging may be an issue for lying regardless of how deep it is.
- The Taskforce spent the remainder of the meeting discussing the structure and recommendations for the final report, and how the recommendations should be implemented. It confirmed that the content and recommendations of the final report need to recognise and potentially leverage off current work that is already happening around winter grazing within government and industry. Discussion also covered:
 - That there is an important relationship between environmental and animal welfare winter grazing issues. However, it cannot be assumed that the solutions for both issues will be the same, or that 'good management practice' is sufficient to meet expectations for both of these.
 - Detection of poor performers and recognition of responsibilities along the supply chain of winter grazing will be key components of mitigating winter grazing issues.
 - Further research is needed to understand the scope of the problem and present viable solutions for future winter seasons.
 - Animal welfare planning must be integrated into wider farm planning i.e Farm
 Environment Plans, with good animal welfare at the forefront of decision making.
