1. Welcome

The Chair welcomed the members, and asked for any other agenda items. The high level of dry matter in Fodderbeet this season was added to the agenda.

The Chair noted that Pania King has resigned from the Group due to competing commitments. MPI will work with Pania and the MPI Maori Agribusiness Directorate to find a replacement with practical farm experience.

2. Minutes from 19 May and 2 June 2020

The minutes from 19 May, which were amended to reflect the conversation on back fencing, were agreed as a true and accurate record. The minutes from 2 June were also agreed as correct. These will be placed on the MPI website for transparency.

The Group went through the actions from the previous meeting and noted them as complete or in progress.

Ospri are able to send communications to graziers identified on their Tb Free database on behalf of the Action Group. A modified version of the recent press release, with emphasis for graziers and farmers to talk to keep in regular contact, has been sent out. Further information from the short-term expectation document will be provided in due course.

Ministry for the Environment and Ministry for Primary Industries staff are preparing the draft environmental regulations to give effect to the Cabinet-agreed policies, announced under the *Action for Healthy Waterways* package. Agencies will then test the draft regulations with a range of stakeholders, including representatives of primary sector bodies. The re-sow requirement under the Intensive Winter Grazing regulation will be tested as part of this process.

Penny to seek clarification on the timing of the Intensive Winter Grazing Regulation under the National Environmental Standards, and when it will come into force.

3. Discussion document – short-term expectations

Ash had revised and circulated the document titled *Winter Grazing Action Group short-term expectations* prior to the meeting.

The group worked through the document, discussing the points where feedback had been received out-of-session and coming to a consensus. A recommendation to provide animals with a suitable lying surface (e.g. by shifting them, or providing bedding) after 48 hours without access to a lying area was reached.

Ash will circulate the document with feedback from today's meeting out-of-session, with the aim of finalising the text and images at the next meeting.

4. Communications

There had been several articles about wintering in the media since the last fortnightly meeting. Links to these were circulated with the papers and included an article about Pāmu's wintering apps, and a farm visit for environmental campaigners hosted by Southland Federated Farmers.

Gray provided a brief update on Compliance. The first few mud complaints for this winter have been received in Southland. The Animal Welfare Inspectors were able to use the recently developed assessment tool to assist with their inspection.

The Communications plan was circulated with the meeting papers. It has been edited to reflect the feedback from previous meetings, as well as communications around the short-term expectations document once this is finalised. This would include a recorded interview with Lindsay, and potentially animated videos.

The Chair closed the meeting at 4:00pm.
