1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for canine semen to Japan DOMSEMEC.JP dated 30 October 2013;
- (ii) the revocation and replacement of DOMSEMEC.JP dated 30 May 2013;
- (iii) the determination under section 62(1) of the format and content of the official assurance for canine semen to Japan

This notice takes effect from the 30 October 2013.

2. Japan requirements

Canine semen exported from New Zealand to Japan must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the canine semen does not satisfy the conditions in the notice. Likewise, if the canine semen does not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

NOTES: This is a new certificate issued due to minor editorial changes.

- 1. Japan MAFF AHD has requested that they be provided with the details of the airport where the consignment will arrive (at least one or two days prior to the date of export). This information should be provided by the Official Veterinarian (Recognised Person), to the Animal Exports Group. The details will then be forwarded by the Animal Exports Group to Japan MAFF AHD.
- 2. Prior to the export, the exporter should ensure that Japan MAFF has been notified of all the documents related to the export.
- 3. Regarding printing of the export certificate, page 1 and page 2 (Official Veterinarian certification) must be printed on security paper, where as page 3 (registered veterinarian certification) must be printed on plain paper and endorsed.
- 4. 'Unit description' refers to the entity that contains the semen e.g. vials, ampoules, straws, test tubes. It is important to state the microchip number of the donor dog on each unit and on the export certificate.

Section 61A Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market'.
