Semen collection centres, semen storage centres, embryo collection teams and embryo production teams can only export germplasm to the European Union if approved to export under the Official Assurance Programme: Requirements for Export of Live Animals and Germplasm (OAP). If the centre/team is currently not approved under the OAP, this application form should accompany the relevant application forms to apply for this approval.

Send the completed application form and other appropriate documentation to the **technical manager of the recognised agency**. A recognised person will carry out an audit of the centre/team and make a recommendation for approval, as appropriate, to the Manager, Animal Imports and Exports Group.

After approval MAF submits a request to the European Union for listing on the EU website. This request must be accompanied, where applicable, by an EU checklist which is completed by the recognised person and forwarded to MAF as part of the listing process.

Collection, processing and storage of germplasm for export to the EU can start after successfully completing the audit but no exports can take place until the centre/team is listed on the EU website.
