# BIRDOHEC.VN 15 AUGUST 2014 – DAY-OLD CHICKS AND HATCHING EGGS TO VIETNAM

## 1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for day-old chicks and hatching eggs to Vietnam: BIRDOHEC.VN dated 15 August 2014;
- (ii) the determination under section 62(1) of the format and content of the official assurance for dayold chicks and hatching eggs to Vietnam.
- (iii) the revocation and replacement of the export requirements for day-old chicks / hatching eggs to Vietnam BIRDOCEC.VIE 20.04.11.

This notice takes effect from the 15<sup>th</sup> of August 2014.

## 2. Vietnam requirements

Day-old chicks and hatching eggs exported from New Zealand to Vietnam must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

## Explanatory note:

If the zoosanitary certificate is not certified then the day-old chicks and hatching eggs do not satisfy the conditions in the notice. Likewise, if the day-old chicks and hatching eggs do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

2.	The flocks / hatcheries of origin have been inspected within thirty (30) days prior to shipment and found free from evidence of communicable diseases including Newcastle disease, avian influenza, fowl typhoid ( <i>S.</i> Gallinarum), ornithosis and pullorum disease ( <i>S.</i> Pullorum).
3.	No cases of the following diseases have occurred on the premises of origin during the last six (6) months:

**NOTES:** This certificate has been updated after publication of the 2013 OIE *Terrestrial Animal* 

*Health Code* with changes to the Avian Influenza chapter. It replaces the previous certificate dated 20 April 2011. It was approved for use by Vietnam on 4 August 2014.

- 1. An import permit is required.
- 2. The Ministry for Primary Industries approves a hatchery and its associated source flocks that supply either hatching eggs and / or day-old poultry as an export approved premises. The export approved premises approval number applies to the hatchery and associated source flocks and should be recorded in section II for eggs exported directly from the source farm.
- 3. Identification of day-old chicks / hatching eggs: the "Description / Identification" column should be used to enter any identification information or other information that would match the consignment to import documentation.
- 4. The "sex" column should be used to indicate "male", "female" or "unsexed".
- 5. A day-old chick means a live chicken during the first seventy-two (72) hours of its life or while it has not been fed, whichever period is shorter.
- 6. The commodity type is indicated in the identification table.
  - Clauses that apply to a specific commodity only should not be deleted, unless specifically indicated.
  - Where a clause refers to more than one commodity type, it is taken to apply only to the commodity type indicated in the identification table.
  - Where a clause refers to a commodity type not indicated in the identification table and deletion is not indicated, it is taken to not apply.
- 7. Where day-old chicks or hatching eggs are required to be inspected within a specified time frame prior to export, a person who is trained or assessed as competent to carry out the task may perform this function (Code of Practice: Export Poultry).
- 8. Where flocks of origin are required to be inspected within a specified time frame prior to export, the poultry veterinarian approved under the Code of Practice: Export Poultry may perform this function.
- 9. Clause 5 applies to day-old chicks only and should be deleted entirely if not applicable.
