The requirements listed in this Importing Country's Phytosanitary Requirement (ICPR) document apply to product of New Zealand only, unless specifically stated. This standard specifies Samoa's phytosanitary requirements for the stated commodities only. If a commodity or commodity grouping is not identified within Section 3 or Section 4 exporters should contact:

Users of this document are strongly advised to review all sections of the ICPR for the determination of a commodity's phytosanitary requirements.
