Background

Since 2004, a total of 9 amendments have been made to the HC spec. Each amendment notice was consulted on in accordance with the requirements of the Animal Products Act, prior to bringing them into effect. To make it easier for stakeholders to view the amended principal notice, an administrative consolidation was developed, which incorporated each of the amendments. However, this consolidation had no legal standing and the original principal notice and amendment notices had to be referred to when referencing any particular provision.

Legal Consolidation of HC Spec

It is now the Ministry for Primary Industries' intention to consolidate the amendments into a single notice, creating a new principal notice. The notices to be legally consolidated are:
